Introduction

OhioHealth is a nationally recognized, not-for-profit, healthcare outreach of the United Methodist Church. Based in Columbus, Ohio, OhioHealth has been serving its communities since 1891. OhioHealth is a family of 35,000 associates, physicians and volunteers. OhioHealth is a system of 12 hospitals and more than 200 ambulatory sites, hospice, home health, medical equipment and other health services spanning a 47-county area. In Fiscal Year 2021, OhioHealth recorded 3 million outpatient visits, 521,445 Emergency Department visits, 161,995 hospital admissions and observations, 79,663 surgeries, 13,740 births, and 500 research studies.

OhioHealth entities are connected by a shared mission "to improve the health of those we serve." With core values of compassion, excellence, stewardship, integrity and inclusion, OhioHealth is committed to delivering quality, convenient, timely healthcare, regardless of ability to pay. OhioHealth is a nationally recognized, not-for-profit, system of faith-based hospitals and healthcare organizations serving 47 Ohio counties. All OhioHealth entities are connected by (a) a mission to "improve the health of those we serve," (b) core values of compassion, excellence, stewardship, integrity and inclusion, and (c) a commitment to deliver high quality, convenient and timely healthcare regardless of ability to pay. OhioHealth was in the top 20 list of companies in the PEOPLE Companies that Care® 2020, which highlights the top United States companies that succeeded in business while demonstrating outstanding respect, care and concern for their employees, communities and environment during the COVID-19 pandemic. In 2020, four OhioHealth hospitals, namely, Riverside Methodist Hospital, Grant Medical Center, Doctors Hospital and Dublin Methodist Hospital were named a 2020 LGBTQ Healthcare Equality Top Performer based on the 2020 Healthcare Equality Index (HEI) administered by the Human Rights Campaign (HRC). OhioHealth Grady Memorial Hospital is located at 561 West Central Avenue, Delaware, Ohio 43015 in Delaware County. Grady Memorial is a 63-bed facility that offers healthcare services such as cancer care, emergency and trauma, heart and vascular care, imaging and radiology, laboratory services, maternity, neuroscience, orthopedics, pain management, rehabilitation and therapy, sleep disorders, surgery and wound care. In fiscal year 2020, Grady Memorial had 63 beds, 2,002 admissions, 6,787 inpatient days, 371 inpatient surgeries, 55,544 outpatient visits, 1,945 outpatient surgeries, 17,661 emergency department visits and 1,056 observation visits. Outpatient sites that are affiliated with Grady Memorial include the OhioHealth Delaware Health Center (801 OhioHealth Boulevard, Delaware, Ohio 43015), OhioHealth Lewis Center Health Center (7853 Pacer Drive, Delaware, Ohio 43015), and OhioHealth Lewis Center Medical Imaging (7651 Stagers Loop, Delaware, Ohio 43015).

Grady Memorial has received various awards and recognitions, including:

1. The Joint Commission Accreditation – OhioHealth Grady Memorial Hospital have achieved The Gold Seal of Approval® of accredited programs, including: (a) OhioHealth Grady Memorial Hospital, (b) Delaware Health Center, and (c) Lewis Center Health Center. Effective August 30, 2019, the accreditation demonstrates that the healthcare organization complies with all the standards for accreditation at the time of onsite survey. The hospital uses clinical practice guidelines and meets performance requirements and certification participation

- requirements at the time of the onsite review (The Joint Commission, 2021). Grady Memorial Hospital successfully implemented the 2019 National Patient Safety Goals (The Joint Commission, 2021).
- American College of Surgeons' Commission on Cancer Accreditation with commendation –
 accreditation was received by OhioHealth Grady Memorial Hospital effective 2021. This signifies exemplary
 cancer leadership, data management, clinical services, research, community outreach and continuous quality
 improvement. Grady Memorial received commendation in clinical research and community education
 (American College of Surgeons, 1996-2021).
- 3. American College of Radiology Accreditation signifies highest standards of care and safety in mammography, magnetic resonance imaging (MRI), computed tomography (including pediatrics), and general and ultrasound services. This was effective in 2020 (American College of Radiology, n.d.).
- 4. **MD** Anderson Cancer Network® Certification a program of MD Anderson Cancer Center, allows our physicians to review patient's diagnosis and treatment with their peers at the MD Anderson Cancer Center, while providing the care needed locally. That means that patients benefit from the latest research and superior cancer expertise in their own communities. The certification was effective in 2015 (OhioHealth 2015-2021)
- 5. **Leapfrog Hospital safety Grade A** signifies that the hospital achieved the standard in preventing and responding to harm (steps to avoid harm, appropriate use of antibiotics), medication safety, maternity care, radiation dose for head scans as part of pediatric care, and critical care. In 2021, Grady Memorial Hospital received its 19th "A" grade (The Leapfrog, 2021).
- 6. Centers for Medicare and Medicare Care Compare 2021 4 Star on overall rating and patient survey The overall rating signifies overall quality performance related to quality measures such as heart attack, pneumonia, readmission rates, and safety of care. The rating on patient rating depicts patient experiences of hospital care. This was effective in 2021.
- Newsweek Best Maternity Hospitals 2020 demonstrates excellence in maternity care such as low rates
 of caesarian section, episiotomy, and early elective deliveries, and following safety protocols to protect
 mothers and babies (Newsweek Digital LLC, 2021).
- 8. Blue Distinction Maternity Services recognizes expertise and efficiency in delivering maternity care based on quality care, treatment expertise and better overall patient results (Blue Cross Blue Shield Association, 2021).
- 2019 Press Ganey® Guardian of Excellence Award Grady Memorial Hospital's Lewis Center's
 Freestanding Emergency Department have reached the 95th percentile for patient experience, engagement or
 clinical quality performance (Press Ganey Associates LLC, 2021).
- 10. Intersocietal Accreditation Commission (IAC) accredited facility accredited for echocardiography, adult stress test, adult transesophageal procedure, adult transthoracic procedure, vascular testing, peripheral arterial testing, peripheral venous testing. This signifies the highest quality vascular diagnostic evaluation utilizing ultrasound imaging while ensuring high quality patient care. This accreditation was effective since January 2021 (Intersocietal Accreditation Commission, 2021).

OhioHealth is dedicated to serving communities through its Community Benefit. In fiscal year 2020, OhioHealth provided a total of \$479.1 million of Community Benefit, comprised of \$122.2 million for charity care, \$284.5 million net cost of Medicaid programs, \$63.9 million net cost of medical education, \$2.2 million subsidized health services, 4.6 million community health services, \$1.5 million in cash and in-kind contributions, and \$0.2 million for research.

The Patient Protection and Affordable Care Act of 2010 requires not-for-profit hospitals to conduct a community health needs assessment (CHNA) once every three years (Internal Revenue Service, 2015). Grady Memorial Hospital obtained the inputs of community stakeholders to identify the priority health needs in Delaware County. Moreover, community stakeholder inputs were obtained in identifying priority factors, priority health outcomes and target age groups to demonstrate alignment of the OhioHealth Grady Memorial Hospital with the State Health Improvement Plan.

The priority health needs that were identified in the CHNA were:

- (1) Mental health and addiction include (a) access to mental health and addiction services, especially those with severe mental illnesses; (b) opioid addiction; (c) depression among adults and youth; and (d) youth mental health and addiction.
- (2) Chronic disease —include diabetes.
- (3) Maternal and Infant/Child Health include children mortality rate among African Americans.
- (4) Access to care include access to mental health providers.
- (5) Social determinants include (a) food insecurity and access to healthy foods; and (b) racism in finding and accessing services, discrimination based on sex and gender, bias in accessing services.

Grady Memorial will develop the Fiscal Year 2023-2025 Implementation Strategy in collaboration with the Delaware Public Health District, and various community stakeholders to demonstrate our lingering commitment to play an active and effective role in the Delaware County community by fulfilling our mission "to improve the health of those we serve." Moreover, Grady Memorial's Implementation Strategy will include actions and strategies that align with the Ohio 2020–2022 State Health Improvement Plan (Ohio Department of Health, n.d.).

A. Definition of the Community Served By the Hospital Facility and How the Community Served Was Determined

A1. Location of hospitals and ZIP codes of communities served.

OhioHealth Grady Memorial Hospital is located at 561 West Central Avenue, Delaware, Ohio 43015. The "community served" by OhioHealth Grady Memorial Hospital is Delaware County, Ohio, as determined by the percentage of patients served from Delaware County. The communities served reside in ZIP codes 43003, 43011, 43015, 43016, 43017, 43021, 43031, 43032, 43035, 43040, 43061, 43064, 43065, 43066, 43074, 43081, 43082, 43235, 43240, 43334, 43342, 43344 and 43356 (Datasheer, L.L.C., 2003-2021).

B. Demographics of the Community

B1. Total population.

In 2019, the estimated population in Delaware County was 209,177. In 2020, the estimated population in Delaware County was 210,630 (Ohio Development Services Agency, n.d.).

B2. Race/Ethnicity.

Among Delaware County residents for 2019, 87.8 percent were White, 3.3 percent were African American, 5.9 percent were Asian, 2.5 percent were Hispanic (of any race), 0.4 percent were other races, 0.1 percent were Native American, 0 percent were Pacific Islander and 2.5 percent were two or more races (Ohio Development Services Agency, n.d.). Total minority represented 14.3 percent of the population (Ohio Development Services Agency, n.d.).

B3. Age.

Among Delaware County residents for 2019, 6.3 percent were younger than 5 years old, 20.7 percent were 5–17 years old, 7.7 percent were 18–24 years old, 25.3 percent were 25–44 years old, 27.2 percent were 45–64 years, and 12.7 percent were 65 years and older. Median age was 38.6 (Ohio Development Services Agency, n.d.).

B4. Income.

Median household income for 2019 was \$104,322 and per capita income was \$74,093. Approximately 3 percent of families and 4.6 percent of individuals had income below the poverty level (Ohio Development Services Agency, n.d.).

C. Existing Healthcare Facilities and Resources within the Community That Are Available To Respond To the Health Needs of the Community

- C1. Healthcare Facilities and Community Resources Addressing Mental Health and Addiction
 - **C1.1. OhioHealth Grady Memorial Hospital** offers patients consults to the OhioHealth Behavioral Health department and OhioHealth Addiction Medicine for psychiatric, mental health and addiction services (OhioHealth, 2015-2021).
 - **C1.2. OhioHealth Lewis Center Health Center –** psychiatric assessments and evaluations are provided in emergency departments. The OhioHealth Lewis Center Health Center offers emergency services, imaging, rehabilitation and other outpatient services (OhioHealth, 2015-2021).
 - **C1.3**. **OhioHealth Primary Care Clinics with Behavioral Health Integration –** offers comprehensive primary care services with access to behavioral health care (OhioHealth, 2015-2021). Examples of OhioHealth Primary Care Clinics include:

- **C1.4.** Central Ohio Narcotics Anonymous Assists Narcotics Anonymous, a nonprofit organization, in sharing their message with persons struggling with narcotic addiction and providing opportunities for people to anonymously discuss their experiences with addiction and help each other cope. There is no fees or dues for membership. Members are required to stop using drugs (Central Ohio Area Narcotics Anonymous, n.d.).
- **C1.5.** Central Ohio Group Fellowship of Alcoholics Anonymous Assists Alcoholics Anonymous groups in central Ohio in conveying their message to persons suffering from alcoholism, and coordinates group meetings. Alcoholics Anonymous is a fellowship of persons who have had an alcohol problem (Alcoholics Anonymous 2021).
- **C1.6.** Access Ohio Mental Health Center of Excellence Provides mental health and addiction services. Access Ohio serves many different populations through (i) inpatient mental health treatment, (ii) residential treatment, (iii) homeless navigator, (iv) HOME Choice, (v) tele psychiatry, and (vi) mental health service in schools (Access Ohio, 2020).
- C1.7. Columbus State Community College Delaware Campus Offers access to mental health and substance abuse counseling services for enrolled students, which includes crisis intervention, mental health, alcohol and drug counseling, substance abuse prevention, consultation, and referral services (Columbus State Community College, 2018-2020). The counseling team also provides educational workshops and seminars to enhance awareness of mental health, alcohol, and drug abuse (Columbus State Community College, 2018-2020).
- **C1.8. Drug-Free Delaware –** A coalition that seeks a drug-free county by preventing underage drinking, and abuse of illegal drugs and prescription medicines. Coalition members represent more than 30 community organizations representing law enforcement, social services, education and the business community (Drug-Free Delaware, 2013-2020).
- C1.9. Delaware County Adult Court, Delaware County Probate/Juvenile Court Probate and Jail Division The Delaware County Probate Court has jurisdiction to issue a court order to involuntarily treat Delaware County residents who abuse alcohol or drugs (Delaware County Juvenile Court, 2015; Delaware County Probate Court, 2015). The Delaware County Probate Court also administers the Delaware County Family Treatment Courts (Delaware County Ohio. Delaware County Juvenile Court, n.d.).
- **C1.10. Delaware County Opiate Task Force** Comprised of local law enforcement, health professionals and educators to fight opiate abuse in Delaware County by information and resources sharing, community participation and actions (Delaware County Opiate Task Force, n.d.). Through efforts of the task force, the National Association of Drug Diversion Investigators-approved locked boxes were placed at Delaware City Police Department, the Delaware County Sheriff's Office, Genoa Township Police Department, Shawnee Hills Police Department, and Sunbury Police Department so it could be used for disposal of unused and outdated medications (Delaware County Opiate Task Force, n.d.).
- **C1.11. Delaware County, Ohio, Sheriff's Office** Includes law enforcement, corrections and support divisions. The Delaware County Sheriff's Office partners with the community to foster alcohol and substance abuse prevention through the speaker's bureau, training and medication disposal. Delaware County residents can safely and conveniently discard unused or expired prescriptions at the Delaware County Jail, Delaware City Police Department, Genoa Township Police Department, Shawnee Hills Police Department and/or Sunbury Police Department (Delaware County Ohio, n.d.)
- C1.12. Delaware-Morrow Mental Health and Recovery Services Board Responsible for planning, funding, evaluating and monitoring health and substance abuse services in Delaware and Morrow counties (Delaware-Morrow Mental Health and Recovery Services Board, 2018). Provider agencies in Delaware County include Center of Vocational Alternatives (COVA), Central Ohio Mental Health Center, Del-Mor Dwellings Corporation, Helpline, Maryhaven, Recovery and Prevention Resources, Safe Harbor Peer Support Services, Syntero, and Turning Point (Delaware-Morrow Mental Health and Recovery Services Board, n.d.).
- **C1.13. Maryhaven** Maryhaven's programs and services in Delaware County include ambulatory detoxification, adult and adolescent outpatient and intensive outpatient groups, addiction and mental health assessments, an adult driver intervention program, individualized or group counseling for mental health and addiction, case management, screening, urine testing, school-based prevention and education, safety programs for persons ages 13–20, outpatient mental health, and anger management (Maryhaven, 2021). School-based prevention programs focus on increasing academic achievement, improving drug control and reducing suicide

risk behaviors. Maryhaven conducts the Positive Leadership Program in Buckeye Valley and Delaware Hayes high schools (Maryhaven, 2021).

- **C1.14. Ohio Wesleyan University** Has a strict policy on alcohol and other drugs indicated in the student handbook, and observes all laws on the sale, purchase and serving of alcoholic beverages, as well as unlawful use of drugs (Ohio Wesleyan University, n.d.) Ohio Wesleyan University also requires incoming freshmen and transfer students to complete the "Think About It" course, which focuses on substance abuse prevention and education (Ohio Wesleyan University, n.d.).
- **C1.15.** Recovery and Prevention Resources of Delaware and Morrow Counties Offers (i) outpatient facilities for adolescents, women and persons with substance abuse disorders, (ii) assists persons struggling with substance abuse, and drug and alcohol addiction and buprenorphine services, and (iii) accepts self-pay, Medicaid and other state-financed health insurance, private health insurance and military insurance (Recovery and Prevention Resources of Delaware and Morrow Counties, 2013).
- **C1.16. Safe Harbor Peer Support Services/Annie's Outreach Center** Provides social, educational and recovery-oriented groups to help adults with mental health disorders lead a healthy and successful life through activities that include families, friends and caregivers (Safe Harbor Peer Support Services, n.d.).
- **C1.17. Delaware Public Health District** provides free naloxone kits with the completion of a training appointment that teaches how to use the kit. This program was made possible by Project DAWN (Delaware Public Health District, n.d.).
- C2. Healthcare Facilities and Community Resources Addressing Chronic Disease (including Diabetes)
 - C2.1. OhioHealth and OhioHealth Grady Memorial Hospital (OhioHealth, 2015-2021).
 - **C2.1.1. Diabetes** offers diabetes prevention, detection, and management programs at various OhioHealth locations, namely (a) McConnell Heart Health Center located at 3773 Olentangy River Road, Columbus, Ohio 43214; (b) OhioHealth Mansfield Hospital located at 335 Glessner Avenue, Mansfield, Ohio 44903; (c) OhioHealth Shelby Hospital located at 199 W. Main Street, Shelby, Ohio 44875; (d) OhioHealth O'Bleness Hospital located at 55 Hospital Drive, Athens, Ohio 45701; and (e) various OhioHealth Physician Group Endocrinology. Diabetes care involves care for Type 2, Type 1 diabetes, gestational diabetes, teaching on the use of insulin pump, continuous glucose monitoring, and referral to nutrition counseling for dietary advice and support.

The **OhioHealth McConnell Heart Health Center** offers a 9-hour education program focused on diabetes self-management care. The classes discuss the following: (a) one-hour appointment with the diabetes nurse educator for a health assessment and goal setting; and (b) four classes, each two hours in length, covering topics of the diabetes disease process, medications, nutrition and carbohydrate counting, exercise and activity, travel, sick-day management, foot care and prevention and management of long-term complications.

The **OhioHealth Mansfield and Shelby Hospitals** offers comprehensive education class series – includes individual assessments with a nurse educator and dietitian, Individual consultation with a nurse educator and/or dietitian for specific needs, and free support group meetings every other month. The nurse explains to the patients with diabetes the following: (a) importance of safely managing diabetes; (b) preventing diabetes complications, (c) use of glucose meter and medications, (d) emotional aspects of diabetes; (e) lifestyle and behavior changes. The dietitian helps patients develop a healthy eating plan that fits one's lifestyle, and enjoyment of tasty foods.

The **OhioHealth Physician Group Endocrinology** offers best quality care to patients with diabetes, endocrine system and metabolic disorders. Care provided by board-certified, fellowship-trained endocrinologists and advanced practice providers include development of individualized treatment plans, disease management and health education on lifestyle changes.

C2.1.2. Heart and vascular health services – Has excellence in diagnosing and treating a wide range of cardiovascular and peripheral vascular conditions. The hospital offers cardiac imaging, cardiac rehabilitation, cardiothoracic surgery, clinical cardiology, electrophysiology, heart failure treatment, interventional cardiology, structural heart treatments and vascular treatments (OhioHealth, 2015-2021).

- **C2.1.3.** Cancer services Provides the most advanced and effective cancer treatment options, based on extensive research and the latest technology. The hospital offers radiation oncology, infusions, supportive care and medical oncology treatments for many cancers, including breast, colorectal, gynecologic, lung, prostate and skin cancers (OhioHealth, 2015-2021).
- **C2.1.4.** Rheumatology (arthritis) services Offers comprehensive care in the diagnosis and treatment of musculoskeletal disease and other systemic autoimmune conditions. Specialists focus on creating a personalized treatment plan to improve patients' quality of life (OhioHealth, 2015-2021).
- **C2.1.5.** Wound Care Offers services for people with hard-to-heal wounds and specialized care for patients with diabetes, burns and wounds that threaten limb loss. Treatment options include hyperbaric oxygen therapy, nutrition counseling and wound care education (OhioHealth, 2015-2021).
- **C2.1.6.** Pain management services Specialists treat chronic aches, severe spasms and pains that interfere with everyday life. Therapies offered include radiofrequency ablation, intraspinal drug therapy, spinal cord stimulation and nerve blocks. Treatments aim to both heal current injuries and prevent future injuries (OhioHealth, 2015-2021).
- **C2.1.7.** Rehabilitation and therapy Provides comprehensive treatment. Treatment aims to help people move better with less pain and get them back to the activities they love (OhioHealth, 2015- 2021).
- **C2.1.8.** Sleep disorder services Combines physical exam results, medical history and, if necessary, sleep studies to help reveal what is causing patients' sleeplessness and what is necessary to treat the problem (OhioHealth, 2015-2021).

C2.2. OhioHealth Delaware Medical Campus

- **C2.2.1.** Cancer services Delaware Medical Campus houses an Infusion Center and Medical Oncology Clinic that includes a physician and patient consultation space, as well as an education and resource area for patients and families (OhioHealth, 2015-2021).
- **C2.2.2.** Pain management services Delaware Medical Campus provides a pain management clinic capable of diagnosing and treating a variety of symptoms, including work-related injuries, persistent pain, headaches, arthritis pain and more (OhioHealth, 2015-2021).
- **C2.2.3.** Sleep services Combines physical exam results, medical history and, if necessary, sleep studies to help reveal what is causing patients' sleeplessness and what is necessary to treat the problem (OhioHealth, 2015-2021).
- **C2.3. Mount Carmel Health System** The Mount Carmel at Lewis Center provides services such as cardiac rehabilitation and chronic disease clinics, indoor track and exercise studios, and full-size pool (Mount Carmel Health System, 2021). The Mount Carmel Health System offers Diabetes Self-Management that is certified by the American Association of Diabetes Educators (Mount Carmel Health System, 2021).
- **C2.4.** The Ohio State University Wexner Medical Center Outpatient Care Lewis Center Includes imaging and mammography, JamesCare Mammography Services, laboratory services, orthopedics, physical therapy, primary care and diabetes, rheumatology, sports medicine (The Ohio State University Wexner Medical Center, 2021).
- **C2.5. Delaware Public Health District** Offers free screenings for blood pressure, blood sugar and cholesterol. The Delaware Public Health District offers wellness services, community services, and environmental services, which may directly or indirectly be related to preventing chronic diseases (Delaware General Health District, 2021).
- **C2.6,** All Ages Family Medicine focuses on all aspects of family medicine for all ages. The clinic helps persons of all ages develop healthy habits to prevent and treat chronic health conditions with minimal medications as possible. All Ages Family Medicine is affiliated with the Central Ohio Primary Care (Central Ohio Primary Care Physicians, Inc., 2021).
- **C2.7. Delaware County Diabetes Association** provides diabetes education and support to people living with diabetes in Delaware County, Ohio.

C3. Healthcare Facilities and Community Resources Addressing Maternal and Infant/Child Health

- **C3.1. OhioHealth Grady Memorial Hospital** offers high quality, compassionate maternity care to ensure the healthiest possible outcome for the mother and her baby. OhioHealth also offers specialty care for mothers who have an increased risk of complications during pregnancy. OhioHealth has a highly trained team of ultrasound technologists, nurse clinicians, genetic counselors, and Maternal-Fetal Medicine specialists. Once a fetal condition is diagnosed, the Maternal-Fetal Medicine experts collaborate with the Nationwide Children's Hospital team and the OB/GYN doctor to create a plan of care. OhioHealth Grady Memorial Hospital has access to the Neonatal Intensive Care Units, which are owned and operated by Nationwide Children's Hospital.
- **C3.1.1.** OhioHealth Obstetrics and Gynecology services provides expert obstetrics (prenatal, postpartum) and gynecology care such as (a) annual well-woman exams, (b) fertility issues; (c) family planning (birth control); (d) screening for Sexually Transmitted Diseases; (e) menopause counseling and hormone therapy; (f) menstruation; (g) clinical breast exams; (h) minimally invasive and non-invasive treatment options for gynecologic conditions; (i) guidance on adult female screenings for breast cancer, osteoporosis, cervical cancer; (j) adolescent care (first gynecology visit, evaluation of menstrual issues, annual PAP smear, Human Papilloma Virus vaccine; treatment for uterine fibroids.
- **C3.1.2.** Breastfeeding support OhioHealth's board-certified lactation consultants help mothers develop skills needed for successful breastfeeding. The OhioHealth team provides breastfeeding support before you deliver, during hospital stay and after taking baby home. Mothers also have access to private breastfeeding consults who provides (a) prenatal breast assessment; (b) attachment and positioning techniques; (c) milk quantity assessment; (d) nipple soreness; and (e) breastfeeding observation. OhioHealth has a Breastfeeding Helpline at 614 566-3434.
- **C3.2. Delaware Public Health District** offers various wellness and community services such as (but not limited to):
- **C3.2.1.** Immunizations and screenings includes flu clinics, adult and childhood clinics for ages 12 and older, adult immunizations, childhood immunizations for hepatitis A, hepatitis B, DTaP, polio, Hib, pneumonia, rotovirus, influenza, measles, mumps, rubella (MMR), varicella (chicken pox), HPV, Tdap, and meningococcal vaccine (Delaware Public Health District 2021).
- C3.2.2. Women, Infants and Children (WIC) aims to serve low-income pregnant, breastfeeding and non-breastfeeding postpartum women, infants and children until 5 years of age with a medical risk or nutrition-related concern. WIC services include (a) nutrition and breastfeeding education and support, (b) access to supplemental, nutritious foods, (c) referrals to healthcare team and community programs and services, (d) checks for height, weight and iron testing (Delaware Public Health District 2021).
- **C3.2.3. Newborn home visits** serves all residents with newborns from Delaware County, including foster and adopted families. Newborn home visits are free. A nurse from the Delaware Public Health District will visit the families with newborn and give them a bag filled with resources and items for their baby. The nurse may also provide Pack-N-Plays for income eligible families. Newborn home visit includes services such as (a) breastfeeding support by a certified lactation specialist, (b) health and weight check-up of newborn and mother, (c) reading materials on normal growth of the baby, safety, nutrition and immunization schedule, (d) referral to other healthcare or community services, (e) access to interpreter services (Delaware Public Health District 2021).
- C3.2.4. Children with Medical Handicaps program refers families with special health care needs to healthcare providers and provides guidance on available financial assistance to families for the services their children require. Examples of services include (but not limited to) (a) identification of children with special health care needs who may benefit from the program; (b) assist families with form completion; (c) provide families with location of CMH providers; (d) refers to physicians, pharmacies, durable medical equipment; (e) educate families about the child's medical plan of care; (f) helps families with navigating their insurance plan; (g) visit families or children in the home, school; and (h) support families in using the services for their child (Delaware Public Health District 2021).

- **C3.2.5.** Delaware County Child Passenger Safety Program also known as Safe Kids Delaware County. The program team does the following: (a) check and ensure car seat or booster seat installations; (b) holds "In Your Neighborhood car Seat Check Events"; (c) distribute free car or booster seats to income eligible Delaware County residents; and (d) education and training on child passenger safety (Delaware Public Health District 2021).
- C4. Healthcare Facilities and Community Resources Addressing Access to Care
 - **C4.1.** OhioHealth Grady Memorial Hospital refer to Section C1.1.
 - C4.2. OhioHealth Lewis Health Center refer to Section C1.2.
 - C4.3. OhioHealth Physician Group Primary Care Physicians that have Behavioral Health Integration refer to Section C1.3.
 - **C4.4. Delaware-Morrow Mental Health and Recovery Services Board** contracts with the Network of Care to provide mental health, substance use prevention, intervention, treatment, and support services for Delaware County residents (Delaware-Morrow Mental Health and recovery Services Board, n.d.)
 - C4.2.1. Del-Mor Dwellings provides housing for persons with disabilities
 - **C4.2.2. HelpLine** 24-hour Crisis Hotline, provides information, makes referrals, and provide prevention services
 - **C4.2.3. Maryhaven** provides education about substance use, prevention services, treatment and mental health treatment services for teens and adults.
 - **C4.2.4.** Recovery and Prevention Resources provides alcohol and drug education, prevention and treatment services for teens and adults
 - **C4.2.5.** Safe Harbor Peer Support Services includes "Annie's Outreach Center" and "No Limits Outreach Center
 - **C4.2.6.** Southeast Healthcare Services offers comprehensive mental health and substance use treatment for adults, and peer, vocational and rehabilitation services
 - C4.2.7. Syntero offers mental health, substance use and prevention services for all age groups
 - **C4.2.8. Turning Point** offers shelter and support services for victims of domestic abuse and violence
 - **C4.5. Mental Health America of Ohio** refers persons in need of mental health services to providers and provides services for individuals and families in maintaining stability and productivity. Examples of services to the central Ohio community include
 - **C4.3.1. Pro Bono Counseling** link volunteer mental health professionals who are licensed and insured with those needing counseling but could not afford it. The mental health professionals provide short-term counseling at no cost.
 - **C4.3.2. Get Connected Program** links callers with an experienced mental health professional who provides assistance, advocacy in understanding caller's problems, assistance in navigating mental health and substance use treatment system; education about client rights in Ohio; and direct referral to Legal Aid Society of Columbus to assist with public benefits, housing, family and domestic conflict, financial issues and other civil legal problems
 - **C4.3.3.** Family Advocate Program connects family members and loved ones of persons living with a mental illness to peer family advocates. Volunteers have knowledge of the mental health system and has experience in dealing with mental illness.

- **C4.3.4.** Perinatal Outreach and Encouragement (POEM) Mental Health for Moms —provides support for prenatal and postpartum depression
 - **C4.3.5.** Support groups ability to meet with people who understand ones mental health conditions
- **C4.6. National Alliance on Mental Illness (NAMI) Delaware and Morrow Counties** works in the community to raise awareness and support and education to people suffering from mental illness (National Alliance on Mental Illness, 2021).
- C5. Healthcare Facilities and Community Resources Addressing Social Determinants of Health
 - **C5.1. United Way of Delaware County**—addresses social determinants of health through various programs such as (but not limited to) (United Way of Delaware County, 2021):
 - **C5.1.1.** Women's Leadership Network supports persons and families in Delaware County to be successful. The Women's Leadership Network donates time and financial gifts to United Way of Delaware County's programs such as (a) Strengthening Families, (b) Supplies for Scholars, and (c) Changing the Odds Scholarship.
 - **C5.1.2. Delaware County Against Human Trafficking Coalition** —a community-wide response to end human trafficking through advocacy, education, prevention, and services
 - **C5.1.3. Delaware County Hunger Alliance** a community-wide collaborative to improve access to healthy foods, nutrition education and resources to promote financial stability.
 - **C5.1.4. Pathways to Hope** assists qualified Delaware County residents with rent, mortgage and utility needs. The Pathways to Hope is a partnership with Family Resource Center, Andrews House, The Salvation Army, People In Need, Inc., of Delaware County, Bridges Community Action Partnership, Delaware County Job and Family Services, HelpLine of Delaware and Morrow Counties, Inc., and Family Promise of Delaware County
 - **C5.1.5.** Strengthening Families fosters learning through community programs and partnerships. Examples of initiatives include Born Learning Trails, support for the Wills Education Center hub, Toy Lending Library, speech pathology and occupational therapy needs assessment, counseling services, after-school teen rooms and programming, education focused on Science, Technology, Engineering, Arts and Math, and emergency food pantries.
 - **C5.1.6.** Supplies for Scholars provides back to school supplies, backpacks and personal care products

D. How Data Was Obtained

OhioHealth Grady Memorial Hospital collected the data from various sources as follows:

- **D1.** The definition of the community served by OhioHealth Grady Memorial Hospital was developed by determining the percentage of patients who resided in Delaware County during fiscal year 2019 and 2020, based on electronic medical records. See **Section A.**
- **D2.** The demographic data of the Delaware County population was obtained from the Ohio Development Services Agency (Ohio Development Services Agency, n.d.). See **Section B.**
- **D3.** Pertinent health data from Ohio's 2019 Community Health Assessment was summarized (Ohio Department of Health, 2020). See **Appendix A**.
- **D4.** Pertinent health and health-related data for Delaware County, Ohio versus State of Ohio, and United States. See **Appendix B.**

No information gaps were identified that may impact the ability to assess health needs during this community health needs assessment process.

E. The Significant Health Needs of the Community

From May 6 to June 22, 2021, the community stakeholders (See Exhibit C for a listing of stakeholders) were requested to review the summary of health and health-related data for Delaware County as well as the Delaware County demographic profile. Participants sent their assessments of the health needs in Delaware County, as determined by the types of health conditions of the population and their experiences in serving persons, families, neighborhoods and communities, by email to Mary Ann G. Abiado, PhD, MSN, RN, maryann.abiado@ohiohealth.com, community health nurse and data management and evaluation specialist, OhioHealth Community Health Partnerships.

On June 23, 2021, OhioHealth Grady Memorial Hospital convened a virtual meeting comprised of 41 community stakeholders (including 9 OhioHealth employees) to review the five significant health needs by category that were identified by various community stakeholders from May 6, 2021 to June 22, 2021. The distribution of votes, the significant health needs, the priority health outcomes under each category and the alignment with the 2020-2022 State Health Improvement Plan are tabulated below. Through a unanimous vote, the community stakeholders prioritized the significant health needs (highlighted below) by which OhioHealth Grady Memorial Hospital must address in its Fiscal Year 2023-2025 Implementation Strategy.

Hence, the priority health needs that will be addressed in the Fiscal Year 2023-2025 OhioHealth Grady Memorial Hospital Implementation Strategy will include:

- 1. **Mental Health and Addiction** includes (a) youth mental health and addiction; (b) access to mental health and addiction services, especially those with severe mental illnesses; (c) opioid addiction; (d) depression among adult and youth. OhioHealth Grady Memorial Hospital will collaborate with the Delaware Public Health District and other community stakeholders in aligning with the 2020-2022 State Health Improvement Plan (SHIP).
- 2. **Chronic Disease** includes (a) diabetes. OhioHealth Grady Memorial Hospital will collaborate with the Delaware Public Health District and other community stakeholders in aligning with the 2020-2022 State Health Improvement Plan (SHIP).
- 3. **Maternal and Infant/Child Health** include (a) children mortality rate among African Americans. OhioHealth Grady Memorial Hospital will collaborate with the Delaware Public Health District and other community stakeholders in aligning with the 2020-2022 State Health Improvement Plan (SHIP).
- 4. Access to Care includes (a) access to mental health providers. In the OhioHealth Grady Memorial Hospital alignment with the State Health Improvement Plan (SHIP), access to care will be considered as a priority factor.
- 5. Social Determinants of Health includes (a) food insecurity and access to healthy foods; and (b) racism in finding and accessing services and sex- and gender-based discrimination in accessing services. In the OhioHealth Grady Memorial Hospital alignment with the State Health Improvement Plan (SHIP), access to care will be considered as a priority factor.

F. Primary and Chronic Disease Needs, and Other Health Issues of Uninsured Persons, Low-income Persons and Minority Groups

Appendices A and B show the health and health-related data affecting the uninsured persons, low-income persons, and minority groups in Delaware County, Ohio.

G. The Process for Identifying and Prioritizing Community Health Needs and Services to Meet Community Health Needs

OhioHealth Grady Memorial Hospital sought public input on the significant health needs affecting Delaware County from May 6, 2021 to June 22, 2021. OhioHealth Grady Memorial Hospital summarized the most recent health and health-related data affecting Delaware County using credible sources such as the Ohio Department of Health, County Health Rankings, Centers for Disease Control and Prevention. The Delaware County demographic profile was obtained from the Ohio Development Services Agency. Apart from the data provided, the OhioHealth Grady Memorial Hospital team communicated to the community stakeholders that their assessments of health needs affecting Delaware County also needs to be based from their experiences in serving persons, families, neighborhoods, and communities

During the June 23, 2021 public meeting, Mary Ann G. Abiado, PhD, MSN, RN, community health nurse and data management and evaluation specialist for OhioHealth, guided the meeting attendees that the prioritization of significant health needs will need to be based from the following criteria: (a) magnitude of the health problem; (b) seriousness of the consequences of the health problem; and (c) feasibility of correcting the problem (Association of State and Territorial Health Officials (2018). The meeting participants voted by placing their votes in the Webex chat box or verbally. The final vote counts were recorded in a Powerpoint voting template created by OhioHealth that were visible to all the participants throughout the duration of the meeting.

During the June 23, 2021 virtual meeting, the community stakeholders prioritized the five significant health needs in Delaware County: (1) mental health and addiction, (2) chronic disease, (3) maternal and infant/child health; (4) access to care, and (5) social determinants of health. Related to OhioHealth Grady Memorial Hospital's alignment with the 2020-2022 State Health Improvement Plan (SHIP), the community stakeholders would like the hospital to partner with the Delaware Public Health District and other community organizations in addressing mental health and addiction, chronic disease and maternal and infant/child health.

H. The Process for Consulting with Persons Representing the Community's Interests and Input Provided

OhioHealth Grady Memorial Hospital consulted with persons representing the community's interest by email communications on the following dates (See Exhibit C for a listing of participants):

Community stakeholders submitted their assessments of significant health needs by email to Mary Ann G. Abiado, PhD, MSN, RN, maryann.abiado@ohiohealth.com. Dr. Abiado responded to the community stakeholders with a bulleted list of significant health needs and encouraged the stakeholder to collaborate with the OhioHealth Grady Memorial Hospital team in developing strategies to address the needs, if selected as one of the priority health needs during the meeting on June 23, 2021.

Dr. Abiado created a voting template where the significant health needs were categorized into five groupings: (a) mental health and addiction, (b) chronic disease, (c) maternal and infant health, (d) access to care and (e) social determinants of health. Dr. Abiado guided the community stakeholders to identify their top three selections among the significant health needs that were identified. In addition, Dr. Abiado asked the community stakeholders to confirm that they recommended that Grady Memorial Hospital aligns with the 2020-2022 State Health Improvement Plan of the state of Ohio.

During the voting sessions, Dr. Abiado stated that prioritization of health needs has to be based from the following criteria: (a) magnitude of the health problem; (b) seriousness of the consequences of the health problem; and (c) feasibility of correcting the problem (Association of State and Territorial Health Officials (2018). When the voting was done for each significant health need, Dr. Abiado asked the community stakeholders to provide input on which specific needs will the hospital address in its Fiscal Year 2023-2025 Implementation Strategy. For additional details, please refer to Sections E and G.

All required sources for community input participated in the community health needs assessment process.

No written comments were received on the prior community health needs assessment report.

Appendix A. Data and Information from the 2019 State Health Assessment

- Appendix A1. Summary of Data and Information from the State Health Assessment, Ohio 2019 (Health Policy Institute of Ohio and Ohio Department of Health, 2019)
 - **Appendix A1.1.** Ohioans' overall wellbeing declined. Premature death, life expectancy and overall health worsened. The leading causes of premature death in 2017 were unintentional injuries (including drug overdose), cancer and heart disease. Ohio's life expectancy dropped from 77.6 years in 2010 to 76.5 years in 2017. Increase in infant deaths, blood pressure, late-stage cancer diagnosis was observed. Black or African Americans life expectancy in 2017 was 72.8 years compared to 77 among Whites.
 - **Appendix A1.2.** Ohioans' lack opportunities to reach full health potential. Ohioans who are black or African American, with low income, with disabilities or live in Appalachian counties have worse health outcomes compared to overall Ohio population.
 - **Appendix A1.3.** Health promotion activities need to be addressed. Interventions need to focus on the following: (i) physical activity, (ii) tobacco use, (iii) access to dental care, (iv) access to mental health, (v) income disparities, (vi) unemployment, (vii) adverse childhood experiences (ACEs), (viii) access to transportation, (ix) lead poisoning and (x) racism.
 - **Appendix A1.4.** Ohio's significant health challenges continue to be mental health and addiction, chronic disease, and maternal and infant health. Ohio's performance worsened or did not improve. Cross-cutting factors include poverty, lack of access to transportation, lack of physical activity, unhealthy eating, and lack of access to care.
 - Appendix A1.5. Ohio's addiction crisis increased prevalence of hepatitis and number of children in foster care.
 - **Appendix A1.6.** Multi-sector collaboration is important to improve health. Approximately 80 percent of modifiable factors that can improve health are related to health behaviors (healthy eating and tobacco cessation) and social determinants of health (housing, transportation, education, employment). Poverty, racism, discrimination, trauma, violence and toxic stress lead to health disparities.

The program offers patients with short-term interventions and monitoring of progress on their risk for depression and anxiety. The OhioHealth primary care practices refer patients to the YMCA Diabetes Prevention Program, which provides support through small groups that learn about healthy habits that reduce a person's chances of developing type 2 diabetes. The Diabetes Prevention Program was funded by the National Institutes of Health and Centers for Disease Control and Prevention. Through the Diabetes Prevention Program, eating healthy, physical activity, and small amount of weight loss (about 5 to 7 percent of body weight) can reduce or delay type 2 diabetes by 58 percent (YMCA of Central Ohio, 2021). The Diabetes Prevention Program is facilitated by a trained lifestyle coach and consist of 25, one-hour sessions held in one year.
